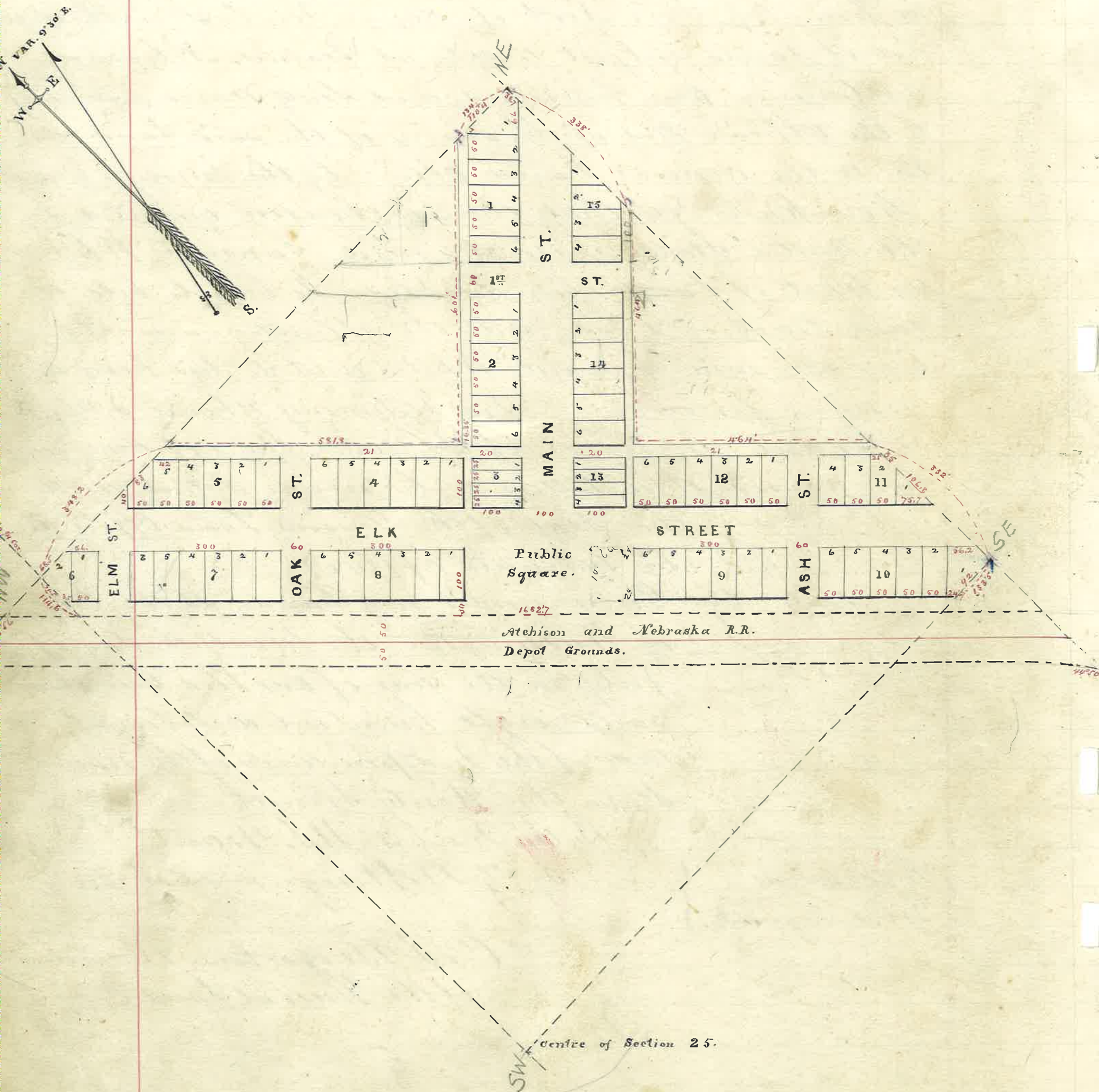

## Description of Elk Creek

Beginning at a point one thousand three hundred and eighteen (1318) feet due south of the  $\frac{1}{4}$  section corner on the north line of section 25 in Town 4 North, Range 11 East of the 6<sup>th</sup> Principal Meridian, thence due East three hundred and forty-eight and two tenths (348.2) feet, thence south  $44^{\circ}04'$  East five hundred and eighty-one and eight tenths (581.8) feet, being parallel to the centre line of the Atchison and Nebraska Rail Road and 381 ft from it, thence North  $45^{\circ}56'$  East six hundred and one (601) feet, thence due East one hundred and thirty-four (134) feet, thence due south three hundred and thirty-eight (338) feet, thence South  $48^{\circ}56'$  Four hundred and sixty-two (462) feet, thence South  $44^{\circ}04'$  Four hundred and sixty-four (464) feet, thence due south three hundred and thirty-two (332) feet, thence due west one hundred and thirty-three and five tenths (133.5) feet, to the right of way line of the A and N. R.R. thence along said right of way line one thousand six hundred and eighty-two and seven tenths (1682.7) feet, thence due North one hundred and fourteen and six tenths (114.6) feet to the place of beginning.
