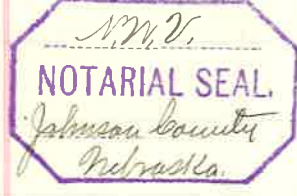

The Block and Lots, are numbered and their dimensions are expressed by the figures thereon; and the widths of streets and alleys are expressed by the figures in red ink in feet. -- The North East corner of this Addition is 260 links due West of N.W. corner of Hecton & Lalicke's Addition. Substantial stakes were driven well down at the corner of all lots, streets, and alleys, and tacks were driven in the top of the stakes, at the precise point of intersecting angles.
